

SEMI-FINALS SET AT CCCOA WOMEN'S BADMINTON CHAMPIONSHIPS

SAN DIEGO, Calif., May 11, 2007 - After the first day of play at the California Community Colleges Commission on Athletics Women's Badminton Championships, held at San Diego City College's Harry West Gymnasium, four student-athletes are in position to win both the singles and doubles titles.

Shannon Hsu (Irvine Valley), Aenoy Bounsavath (San Diego City), and Jordana Barrios (San Diego Mesa) are the top three singles seeds, respectively, from the Orange Empire Conference. The other singles semi-finalist is Maggie Ho (Skyline), the No. 1-seed from the Coast Conference. Hsu will be matched up against Barrios and the winner will meet the victor of the Bounsavath-Ho match in the final.

Those same matchups will take place in the doubles semi-finals. Hsu will be teamed up with Tracey Nie and Barrios with Nancy Truong. SDCC's Bounsavath will partner with Amy Tu and Ho with Casey Spinetti. Complete results for Friday's matches and the schedule for Saturday follow:
